 - C.- **Prove of Mexican liability insurance.**
2. A reservation fee will be required equal to one month's slip fees, which will be applied to the *security deposit*, if application is accepted. If is denied the *deposit* will be returned. This deposit will hold a slip for 30 days only, after which the *deposit* will be forfeited, and reservation cancelled, unless special arrangements are made with the marina management.
3. If you become a tenant, the *security deposit* is held until your final departure from the marina and will be refunded, less any balance owed to the marina at that time.
